#### Items and Actions

#### 1. ATTENDEES

#### 1. Safety Committee Update - CP

CP presented a brief update on Concussion protocol, Heat Stroke and Heat exhaustion.

# 5. 2022 Masters - MS

Intent to Enter form due date moved to 12 weeks prior to event (5<sup>th</sup> July) to assist with event coordination and scheduling. The official entry form is still due 4 weeks prior to the event.

MS called for the council's assistance in publicising event within the federations.

Thank you to Svenja & John, who compiled a list of skiers from the ranking list, who haven't skied in recent events so they can invite them.

Funding - needing more sponsors. Betsy Gilman and MS proposed a 'Century Club' 25 members/skiers make a \$1000 or more sponsorship; they will receive a 'Century Club' T-Shirt and recognition at the Tournament. MS addressed Seeding Scores, as per rule 19.07.

MS proposed that scores be seeded from the day after the Canadian World Tournament, RG agreed, as it only determines the order off the dock.

Council agrees, scores for the 2022 Masters shall be seeded from 19<sup>th</sup> August 2018 until 4 weeks prior to competition.

# 10. Federation Development - GS

GS announced he is in the process of adding Barefoot to all federations, trying to open more federations which will include Barefoot, and assist in the promotion of Barefoot. GB mentioned that attempts to communicate with South Africa & Asia have gone unanswered, BP elaborated that the IWWF board needs to encourage the federations to recognise all disciplines.

# 13. Europe Update – LV

Europe had their first post Congress for their election with 80 attendees. The European Council was re-elected, for 4 years. The European Champions 27<sup>th</sup> - 30<sup>th</sup> July in Chartres, France, it will officially be on the EMS Calendar soon, LAO will be signed next week by French federation. There will be a judge's seminar on a European Level, in Frankfurt, Germany, from the 20<sup>th</sup>-21<sup>st</sup> March as they have lost experienced officials due to Covid.

#### **18. General Business**

Re: 2022 Masters- The Council to assist in generating publicity, asking skiers to participate.

Under 23's records, proposed to begin at the Under 23's Worlds, more discussions to come. JC asked, what is the age qualification for the Under 23 category? MS elaborated, if you are 22 on December 31st the year prior to the tournament, you are eligible to compete.

Juniors will be counted from the Junior year of 2022, ie. They must be under 17 as at 31<sup>st</sup> December 2021 to compete at the 2023 Junior Worlds, as per the rules.

MS addressed eligibility of the 2022 Master's, there is no qualifying scores, providing you are in the correct age group and your federation certifies your ability to compete. MS clarified, every skier from each country is a team member for their respective country with the best scores from men & women in each age group total to decide the winning team.
